Treasurer's report

- Total **Income** Through October 2022: **\$414,954** (\$2,498 under Budget)
- Total **Expense** through October 2022: **\$273,834** (\$18,532 under budget)
- **Cash Balance** as of 10/31/2022: \$103,236 in interest bearing MM and \$332,881 in checking. Total cash on hand: **\$435,236**
- 2023 Budget for \$514,778 income and \$521,703 Expense (Net income: \$6,925) was presented, discussed, and approved with the caveat that Eileen

may come back to the board for increased spending as to discuss expenses that were removed to keep it a balanced budget.

Program Update:

- Total books distributed YTD = 490,987 VS YTD 2021 414,713.
- Total Books Distributed since 2012 = 3,655,170

Program Highlights-

Community Book Fairs: 172,883 distributed YTD through program

Order delivery/pick up: 128,893 distributed YTD through program – Note: lack

of inventory prevented increased distribution.

Ongoing deliveries: 42,261 distributed to LIRR, Correctional Facilities, etc

Overseas: 138,810 through our partner programs

o **Marathon:** 33K raised 11 runners. we will try to increase the # of Runners.

o **Grants/Foundations:** Budgeted \$234,500 Actual: \$225,994 – \$17k uncollectible from Bruderman written off.

o **Corporate:** Budgeted \$80,350 Actual: \$106,353

o **Individuals:** Budgeted \$113,000 Actual: \$93,497

o **Registration Fee:** Budgeted \$11,000 Actual \$9,608

o **Book sales:** Budgeted \$24,000 Actual \$27,642
